

# **Software Sector Report**

### Executive Summary Software Q4 2021

- In Q4 2021, M&A deal activity, private financing activity, and software performance in the financial markets slowed down
  - IGV tech-software index declined 1.8% in Q4
  - Platform outperformed the other software segments in 2021, achieving 42.7% growth in market cap
- Q4 '21 saw ~\$57 billion in financing deal value and ~\$129 billion in M&A deal value
  - 614 financings, 116.2% higher than Q4 '20
  - 581 M&A transactions, 9.2% higher than Q4 '20
- Significant M&A activity in Q4 was headlined by large acquisitions in the healthtech space: Oracle's \$29.7 billion acquisition of Cerner and Bain Capital/Hellman & Friedman's \$17.0 billion acquisition of Athenahealth
- Financial software had some of the largest financing deals in Q4 '21, led by the \$750 million financing of Celsius Network, the \$725 million financing of Forte, and the \$421 million financing of FTX






Quarterly Financing Deal Count (1)(2)

#### Past 12 Months





Subsector Top Players and Key Operating Stats














#### EV/2021A Revenue




#### 2021A/2020A Revenue Growth






#### EV/2021A EBITDA




#### 2021A EBITDA Margin

#### 2022E EBITDA Margin












